Conditions for Acceptance of Color Illustrations

Illustrations in full color are accepted for publication in ARCHIVES OF NEUROLOGY if the editor believes that color will add significantly to the published manuscript.

When color illustrations are accepted, the American Medical Association will pay part of the expense of reproduction and printing for the first page, the remainder to be borne by the author or the institution with which he is affiliated.

After deducting AMA's contribution the author's share is \$275 for a page of color. When a manuscript contains a number of illustrations necessitating the printing of more than one journal page the author charge is \$350 per page for the number of pages exceeding one. The senior author, unless otherwise designated, receives 500 complimentary reprints of his color page(s).

Color transparencies must be submitted for evaluation. Do not send color prints unless accompanied by original transparencies.

Generally, it is not possible to include more than six color illustrations per page.
